The Agency filed a motion for modification of child support on May 15, 2020 at its own request. The moving party has the burden of showing changed circumstances since the last support order. There is a change of Respondent's income alleged and the initial burden is met.

Absent objection and contrary evidence by the parties presented at the time of hearing, the court intends to grant the modification as outlined in the Agency pleading. Absent objection and contrary evidence by the parties, Guideline support will be modified to \$302 per month, payable by Respondent, effective June1, 2020.

The Court intends to adopt new springing language indicating that language in any prior orders which include administrative relief without further order of the court is no longer applicable.
